Invitation for Bids for the **Construction of 2nd, 3rd, and 4th floor of office Building**

The Government of Nepal [GoN] **has allocated funds** towards the cost of [**Construction of 2nd, 3rd, and 4th floor of office Building**] and intends to apply part of the funds to cover eligible payments under the Contract for **[Bheri/W12/2076/077]**¹. Bidding is open to all eligible as per Section V of bidding document..
2. **[Bheri Municipality]** invites sealed bids or electronic bids from eligible bidders for the construction of **[Construction of 2nd, 3rd, and 4th floor of office Building]** under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **[NRs 30,745,000.00]**
 - Minimum Work experience of similar size and nature: **[at least complete one Project of similar building work and 18200000.00 with out vat]**
3. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn enclosed in one sealed envelope as per the provision of ITB 21 of the Bidding Document.
