5. Pre-bid meeting shall be held at **Bheri Municipality, Khalanga Jajarkot, at 2:00 PM on 2075/07/12.**
6. Interested Bidders shall submit the electronic Bids through www.bolpatra.gov.np/egg to the above office of **Bheri Municipality Office of municipal executive, Khalanga Jajarkot on or before 12:00 Noon on 2075/07/28**
7. Bids shall be opened in presence of Bidders' representatives who choose to attend on **2:00 PM on 2075/07/28** at the office of **Bheri municipality office khalanga jajarkot**. Bids must be valid for a period of **90 (Ninety)** counting from the day of bid opening and must be accompanied by bid security, amounting to a minimum of **NRS**, which shall be valid for minimum 30 days beyond the bid validity period
8. If the last date of submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
9. Bidders who choose to submit the bid by E-Bidding System, must submit the original copies (Hard copy) of mandatory documents to Bheri Municipality Office, Khalanga jajarkot within the Five days of last date of Bid submission. Non submission of the hard copy by the bidders within the specified time shall be considered as non responsive and may cause forfeiture of bid security.
